The [National Coalition for Sexual Health](#) (NCSH) is launching a new tool "[Sexual Health Questions to Ask All Patients](#)" to help healthcare providers integrate comprehensive and practical questions into a sexual health history or into conversations with their patients.

This standalone tool builds upon CDC's 5 Ps approach to sexual history taking that asks patients about 1) Partners 2) Practices 3) Past History of STIs 4) Protection, and 5) Pregnancy Prevention/Reproductive Life Plan. The NCSH has developed a 6th P to help providers talk with patients about sexual pleasure, problems, and pride. Specifically, questions explore sexual satisfaction, functioning, and concerns, along with support for one's gender identity and sexual orientation.

Developed by NCSH's Health Care Action Group, which is comprised of leading health care provider organizations, the tool has also been integrated into [Sexual Health and Your Patients: A Provider Guide](#). This tool is available at no cost through NCSH's website; you can use it in your clinical practice, and share it with your colleagues.
